Shared experiences and teachings about Indigenous culture were presented by Okimaw Chief Henry Lewis, Bishop Mark Hagemoen, Chief Wilton Littlechild, Archbishop Richard Smith, and Knowledge-Keeper, Lyndon Linklater. Each presentation was not only informational, but inspiring and engaging. Catholic Trustees, Directors, and guests experienced opportunities to deepen their knowledge and understandings of Indigenous culture, history, knowledge, and perspective.

The Flag Dance and the Kakismakamik Culture Centre (which houses the Eagle Staff when not in use, photo) at Holy Rosary High School instilled humility, pride,

respect, and awareness of embracing Indigenous culture, knowledge and spirituality. On Sunday, everyone gathered outside to pray the Living Rosary. Cultural Indigenous teaching sessions followed: Ribbon Skirt Teachings by Cynthia Young; Strawberry Teachings by Tinisha Young; Pipe Ceremony Teaching by Mike Young; and Sweat Teachings by Kieran Young. The morning ended with a panel which included Lyndon Linklater, Cynthia Young and Stephanie Brown Munro. Each day began with smudging and was truly a wonderful weekend to journey and engage in hope together.
