  As the Director of Education announced his retirement effective July 31, 2025, the Director performance assessment will not take place.

# 12. Governance - Executive Council Reporting

- a. Enterprise Risk Management (ERM) Report Duty to Accommodate
  - J. Landry presented the Enterprise Risk Management (ERM) Report Duty to Accommodate. Key points from the presentation include:
  - 1. Supporting Students with Potentially Life-Threatening Medical Conditions
  - 2. Saskatchewan Education Leadership Unit (SELU) RCSD Student Services Comprehensive Three-Year Review to enhance support systems and mitigate risks across the division:
  - Phase One (2021-2022): Focused on student support teams, educational psychologist services, and grade 8/9 transitions. The review led to the alignment of procedures across school divisions to reduce risks.
  - Phase Two (2022-2023): Examined the Elementary Functionally Academic Program (EFAP) and Functionally Integrated Program (FIP), addressing safety-related recommendations and areas of support.
  - Phase Three (2023-2024): Conducted an internal review of counseling and learning resource teacher services through strategic dialogue, resource mapping, and gap analysis. This phase also included the "Telling St. Luke School's Learning Community Story" project at St. Luke School.
  - 3. Inclusion and Intervention Plans (IIP) including a breakdown by diagnosis.
  - 4. Partner Agencies
  - 5. Mitigating Risks- Current & Future

The significant increase in students with diverse needs and official diagnoses has placed greater demand on the division's resources, support services, and staff.
