8. Decision Items

a. 14016: Advance Placement (AP) Exam Fee Increase

K. Ehman shared that historically RCSD has paid for all Advanced Placement exams for students enrolled in an AP credit course offered by our instructional staff. In the past decade, the number of students accessing AP course opportunities has significantly increased . As well, the base cost of each AP exam has increased. K. Ehman suggested the one-time AP fee is increased from \$25 to \$125 commencing the 2024-25 school year to help offset the cost of AP exams, \$25 will remain in the school budget as per the current fee structure, and \$100 will be transferred to the division budget responsible for paying the exam invoices. Students could write up to 5 exams for one fee of \$125. This would be equivalent of 5 university courses.

R. BAST: That the one-time Advanced Placement fee be increased from \$25 to \$125 which will cover up to five exams, commencing the 2024-25 school year to help offset the cost of AP exams.

b. 14017: Proposed Name for the New North Regina Joint Use School The Regina Catholic School Division is excitedly anticipating the opening of the new North Regina Joint Use School in Fall 2026. The next step in the planning process is to name the new school which will create a specific identity as St. Michael and St. Peter Schools become one. After completing a thorough review of the public's submitted names, the Board then discerned the Naming Committee's top five choices at the April 22, 2024, Board Planning Meeting. The new school name presented for approval is St. Raphael School.
