- 8. Discussion
  - a. 2023 Audit Engagement Letter

Trustees reviewed and completed the audit questionnaire and all six Trustees signed the Audit Engagement Letter.

- b. Student Enrolment August 31, 2023
  - Enrolment continues to grow at un unprecedented rate.
  - A form has been created for school Administration to fill out mid-year to request additional staffing including teachers and support staff. Requests will be weighted based on their level of emergency.
  - -A plan to address mid-year funding has not been announced by the Ministry at this point. We will continue our advocacy efforts.
  - -Current enrolment head-count is already above what was budgeted.

- -Executive Council is already looking at enrolment "hot-spots" and proactively prepping and visiting sites early to make sure any permits required to add additional relocatables are in place. Possible challenges are property lines and new building codes.
- -Multilingual and Multicultural Services has pulled several EAL teachers from schools to assist with newcomer assessments in order to get students/families off the assessment waiting list and into schools.

## c. 2022-23 Quarter 3 Forecast

The Division is forecasting a deficit of \$8.141 million. After approved use of reserves, we are forecasting to be in a deficit position of \$874 thousand. Spending has been halted on some items to bring this deficit down.

Financial Pressures leading the deficit:

- Enrolments after September 30th lead to over 600 unfunded students in the 2022-23 school year. It is essential to receive mid-year funding in order to not remain in a deficit-free situation.
- Salaries: Current accounting software does not accurately track salary step increases. The Division will need to consider updated software in order to get proper salary tracking.

### 9. Governance

  - -S. Chase and S. Weninger sent a letter to Jeremy Cockrill, Minister of Education regarding the concerns and consequences that the August 22 Ministry Directives will have on The Regina Catholic School Division.
  - -The Board shared it was important that the letter be shared publicly to show the concerns the division has with the directives.
  - -S. Weninger shared that there was no consultation with the school division from the Ministry on the directives.
  - -S. Weninger shared the timing of the directive announcement days prior to the start of the new school year was harmful, as there was no time for the division to thoughtfully process and plan for the changes and responses required of the division to meet the directives.
  - -Regina Catholic is dedicated to our commitment of 'Safer Spaces' putting students and families first.
